### **The role:**

To play a key role in driving forward the success of EoLP through the effective strategic leadership and management of the financial aspects of the Charity. This will include management of diverse income streams, effective use/stewardship of resources and fit for purpose financial reporting. The post holder will have a key role in strategic and corporate financial reporting (both to the Board and to the Leadership and Management Team (LMT) and statutory accounts.

The post holder will be working alongside a Management Accounting Officer who undertakes all the day to day finance transactions and reconciliations.

The postholder will utilise highly developed specialist knowledge, underpinned by theory and experience. They will have full working knowledge of Financial Strategy and Reporting Standards. They will be competent in the use and interpretation of data from financial systems and Microsoft packages e.g. spreadsheets, ledgers, etc. They will have knowledge of financial policies, standards, legislation and experience of controls assurance and governance frameworks.

- Advanced technical accounting practice and expertise
- An understanding of good practice in charity financial management
- An understanding of the range of income types for charitable organisations
