#### Pallaborative North West Ketamine case note survey 2021- now open for data collection

Two researchers in the ethics of palliative care – Dr Martyna TOMCZYK (PhD) and Prof. Ralf J. # The All-Party Parliamentary Group (APPG) on Hospice and End of Life Care review into the lasting impact of COVID-19 on death, dying and bereavement in England

As part of this review, it is requesting written evidence from those who have provided palliative and end of life care during the pandemic on their experiences, innovations and adaptions in care and the lasting impacts of the crisis on the sector and its workforce.

The APPG plans to use the evidence submitted to this review to inform recommendations to Government and the hospice and end of life care sector to ensure lessons learned during the pandemic, as well as new challenges, are not forgotten and lead to an improvement in people's experiences of death, dying and bereavement.
