#### Homeless palliative care service featured in national NHS framework

- published on 10 October This focuses on the role that the NHS plays in improving healthcare, and how partnerships across sectors such as housing and the voluntary and community sector play a key role in addressing wider determinants of health. The Liverpool Homeless Palliative Care Multidisciplinary Team was selected as one of ten case studies featured as an example of good practice in inclusion health. #### New cancer service cuts hospital stays for elderly – The Times 23/10/23

Over 200 patients have been treated by a new specialist cancer service for elderly patients at the Christie Hospital in Manchester, which was set up to meet the more complex care needs of an ageing population. The service has nearly halved the number of unplanned hospital admissions among older cancer patients, improving survival and quality of life. Read more here: <u>The Times 23/10/23</u>.

#### New palliative care hub opens at Wigan Infirmary – Wigan Today 18/11/23

A former ward has been transformed into a new Macmillan Supportive and Palliative Care Hub at Wigan Infirmary, providing new space to support patients and their families. Prof Chris Brookes, chairman-elect of Wigan Warriors and chief medical officer of the Rugby Football League and England Rugby League officially opened the area that is predicted to "transform the way in which end-of-life care and support is delivered" by the trust. New sessions available helps learners to recognise palliative care needs – e-ELCA

The End-of-Life Care For All (e-ELCA) e-learning programme now features a new session on <u>recognising palliative care needs</u> The resource describes common palliative care needs and offers guidance on how to identify these needs and provide the most appropriate care on an individual basis. e-ELCA also features newly updated sessions covering a range of topics including communicating with people with speech, language and other communication difficulties, assessment of anxiety, depression and delirium to spiritual care and quality of life. An existing session on dying as a prisoner has also been updated.

**Communities of Practice – Palliative and End of Life Care for People Experiencing Homelessness** A new programme has been developed to help set up local, multidisciplinary/multi-professional communities of practice. These aim to provide a source of support for professionals, whilst ultimately improving the care that people with advanced ill health and who are experiencing homelessness receive.
